Old Business:

Pavilion-Bid for pavilion has been awarded to J.Pinto Construction and Supervisor Radtke has a meeting with the builder tomorrow morning to sign agreements. The Interlochen Women's Group generously donated \$200 for the purchase of a picnic table for the new pavilion. We appreciate their continued support.

Airport Improvements-Anderson has been authorized to purchase FAA required signs. Mr. Anderson will be doing brush clean-up and coordinating re-installation of the fencing.

Basketball Hoops-Mr. Anderson volunteered to execute the purchase backboards on our behalf to utilize his discounted pricing available to him as a basketball coach, which GLT will then reimburse for per Supervisor Radtke.

Clean-up Day- is May 13 from 8am to noon. Volunteers are needed

Youth Ball Leagues-Clark reported we have 16 applications so far with most of them t-ball and we extended the deadline to May 1. We are set with sponsors.

Family Fun Day-is June 17 and we have received correspondence from Bonnie Woolsey to update us on their progress. Clark has the pavilion blocked off for the weekend. Supervisor Radtke will make sure township maintenance staff is available for the weekend. Clark would like to see more volunteers for the event and asked for input on how to achieve this. Leedy suggested Clark become part of the Chamber's committee to bring back information on needs for volunteers or financial. Leedy suggested working with the Chamber to break out the volunteer opportunities into small tasks and timeframes and asking groups such as the clubs, scouts and daycares to participate.

New Business:

Cameras-Leedy is in progress of applying for a security camera grant for the airport and nearby grounds.

Adult Softball-Supervisor Radtke met with Jim Pierce about Jim running an adult co-ed softball league starting yet this season, for \$1000 for this season. Jim is interested and has umpires lined up. Supervisor Radtke asked the parks committee whether they are interested. McDonald moved to recommend the Supervisor proceed with softball program as presented. Support by Habedank. Motion carries.
