Reconvened at 5:00 p.m. All board members present.


Schroeter asked that misconduct be removed from the resolution.

**Resolution # 06192017.1**


At a Special Meeting June 19, 2017 of the Green Lake Board of Trustees the following action was taken and resolution passed:


BE IT RESOLVED BY The Green Lake Township Board of Trustees as follows:
